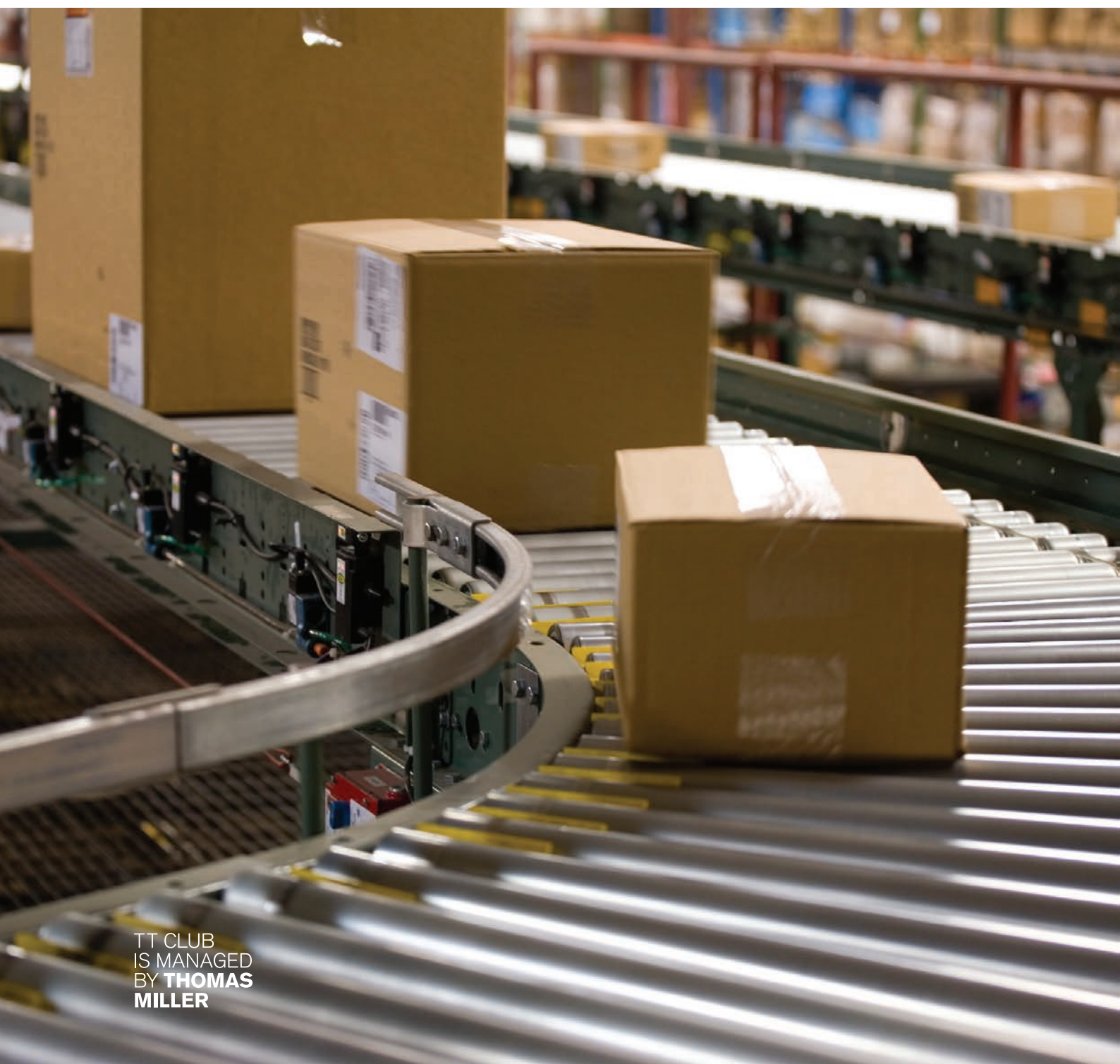

## Transport & Logistics Operator Cover

The role of the transport operator has evolved over the years to include companies that operate freight and logistics services across all modes of transport. This encompasses freight forwarders, railway or stack train operators, NVOs, inland waterway operators, trailer operators, parcel carriers, tank or container operators, air freight companies, road hauliers and warehouse/depot businesses and logistics operators such as 3PL and 4PL providers.



Today's complex supply chain demands more value-added functions including labelling, procurement, vendor management, sub-assembly, and merge-in-transit. Consequently, operators are exposed to ever greater risks as they are asked to accept more onerous liabilities, such as full-value contracts. To cope with this diverse combination of risks, TT Club has created a comprehensive package of insurance protection, reducing gaps and overlaps in cover and minimising the need to buy separate insurances.



### Standard insurance cover includes:

- Business interruption risks
- Contents
- Fire and tenants legal liability

- Infringement of personal rights
- Per diem tank container costs
- Liabilities for advice and information
