This notice applies to all TT Club Members including those Members who insure their risks with TT Club Mutual Insurance N.V. where TT Club Mutual Insurance Ltd acts as reinsurers.

Please note that with effect from 12th March 2026 the Club has updated the list of excluded areas under its covers for War Risks, Piracy, Strikes Riots & Terrorist Risks, to reflect changes in the Listed Areas issued by the Joint War Committee (JWC) circular JWC033.

Added:

Bahrain
Djibouti
Kuwait
Oman
Qatar

Amended:

Persian/Arabian Gulf, Gulf of Oman, Indian Ocean, Gulf of Aden and Southern Red Sea

The waters enclosed by the following boundaries:

- a) On the northwest, by the Red Sea, south of Latitude 18°N;
- b) On the northeast, from Pakistan coastline at 25°19'15"N, 65°E;
- c) On the east, by a line to high seas point 10°48'N, 65°E, thence to high seas point 10°48'N, 60°15'E, thence to high seas point 6°45'S, 48°45'E;
- d) and on the southwest, by the Somalia border at 1°40'S, 41°34'E, to high seas point at 6°45'S, 48°45'E;

CANCELLATION OF COVER FOR WAR RISKS, PIRACY, STRIKES RIOT & TERRORIST RISKS REINSTATEMENT COVER

With effect from midnight GMT on the 12th March 2026 cover for War Risks, Piracy, Strikes Riots & Terrorist Risks in Listed Areas is cancelled.

Cover is automatically reinstated from midnight GMT on the 12th March 2026 except for War Risks, Strikes Riots & Terrorist Risks for claims arising in:

1. Iran and Iranian waters including coastal waters up to 12 nautical miles offshore
2. Persian/Arabian Gulf and adjacent waters as defined

Persian/Arabian Gulf and adjacent waters including the Gulf of Oman and waters west of the line from Oman's territorial limit off Cape al-Hadd at 22°42.5'N, 59°54.5'E northeast to the Iran-Pakistan border at 25°10.5'N, 61°37.5'E

Conclusion

For those Members who have not purchased reinstatement cover including but not limited to AT&C SN1305/1306/1307 and S0306/307/308 for War Risks, Piracy and Strikes Riots & Terrorists Risks the list of areas where you are not covered for these risks has expanded.

For those Members who have purchased reinstatement cover including but not limited to AT&C SN1305/1306/1307 and S0306/307/308 for War Risks, Piracy and Strikes Riots & Terrorists Risks you will no longer be covered for War Risks and Strikes Riots & Terrorists Risks in Iran or the Persian/Arabian Gulf (as defined above). The Managers may consider reinstatement of this cover for an additional premium.
